IN 2017, 207 YOUTH WERE SERVED IN THE AFTERSCHOOL CENTER, 163 CHILDREN ATTENDED THE SUPER SATURDAY SUMMER PROGRAM, AND 46 CHILDREN ATTENDED WEEKLY JAM. IN ADDITION, 98 YOUTH PARTICIPATED IN OUR CAMPING, COLLEGE AND CAREER FIELD TRIPS, 54 YOUTH ATTENDED YOUTH GROUP, 164 YOUTH PARTICIPATED IN OUR EDUCATIONAL ADVANCEMENT PROGRAM, AND 43 YOUTH PARTICIPATED IN OUR COMMUNITY SERVICE AND YOUTH EMPLOYMENT PROGRAMS.
